 <u>Summary</u>: The Triple Bottom Line (TBL) approach enhances assessment of programs, projects, and
 policies by adding two additional criteria to the usual financial benefit-cost analysis (BCA) –
 Environmental and Social impacts. More and more sustainable communities (and businesses) are doing
 it. Or are they? And, how can we measure the social impacts in a defensible and systematic way?
- Dr. Malak Anshassi, University of Florida An Integrated Tool for Local Government to Track Materials Management

<u>Summary</u>: Over the last five years the concept of Sustainable Materials Management (SMM) has been widely received in many parts of the US, including Florida. To investigate application of SMM in solid waste management planning the University of Florida have developed a tool for Florida decision makers. We will provide an overview of SMM and the tool's development history, as well as walkthrough potential application of the tool for SMM-based waste management planning purposes.

• Elizabeth Biser, The Recycling Partnership – The Role of Policy in Leveling Up the U.S. Recycling System

<u>Summary</u>: From state legislatures to the halls of Congress, conversations around recycling policy are picking up steam. The Recycling Partnership, a national non-profit that works with companies and communities to strengthen public recycling systems, formed a policy arm two years ago with the goal of accelerating the move towards a more circular economy. Hear how they worked with partners throughout the value chain to develop a shared-responsibility policy approach to sustainably funding the U.S. recycling system. ***For clarification, this presentation is being given by the independent national organization.**

<u>Summary</u>: Hear from EPA and their announcement of the national Anaerobic Digestion Request for Proposals. The notice announces the availability of funds and solicits applications that will accelerate the development of new or enhance/increase existing anaerobic digestion capacity and infrastructure in the United States. Anaerobic digestion (AD) is the natural process in which microorganisms break down organic (plant and animal) materials.
