Emphasis is placed on annually honoring an individual or organization that are pursuing significantly increased awareness which motivates recycling, composting, waste reduction and other sustainability efforts. The award winner will display exemplary practices in their respective organizations.

The award recognizes those in the field of recycling who have made a sustained and significant contribution to the field through their work. It is not restricted with respect to the level of work or the type of work that individuals may undertake during their professional lives but seeks to recognize individuals who are making notable contributions to the field of recycling.
